DESCRIPTION OF BUILDING PRODUCT

Cemix tiling grout is supplied as a powder (flexible coloured grout) or as a ready to use product (pre-mixed grout). The products have a cementitious base and additives that provides resistance to a broad spectrum of moulds and bacteria.

Grouts are used as binders that act as a filler between tiles and absorb slight movement caused as a result of tile expansion.

When professionally installed, the Cemix tiling grout may contribute to compliance with E3 (Internal Moisture) and E2 (External Moisture).

SCOPE OF USE & LIMITATIONS

Cemix flexible coloured grout and pre-mixed grout are suitable for interior and exterior wall and floor applications. They are supplied in a variety of uses and are intended for use with tiles with joints 1mm – 5mm in width.

Pre-mixed grout is not suitable for use where the grout may be subject to water immersion such as showers, baths, swimming pools. Cemix flexible coloured grout may be used for these applications provided that it is used with Cemix Tile Bond Latex.

CONTRIBUTION TO BUILDING WORK CODE OBLIGATIONS

Grouting does not have building code obligations. Code contribution arises when professionally applied.

B1 (Structure), applicable performance criteria. The grouting increases the durability of compliance.

E2 (External Moisture) & E3 (Internal Moisture), applicable performance criteria. The grouting increases the durability of compliance.

B2 (Durability), B2.3.1(a). The durability of grouting is well established in NZ based on in-service use.

F2 (Hazardous Building Materials), F2.3.1. Grouting is not considered hazardous and do not emit harmful gases.
