DESCRIPTION OF BUILDING PRODUCT

Cemix supplies Roof & Gutter Repair Tape, Rubberguard Peel and Stick Tape, and Roof & Gutter Waterproofer. (membrane). These products are intended to be used together to waterproof roofs, gutters as well as cementitious, metal and timber surfaces.

The membrane is a grey, flexible, UV resistant, rubber-based waterproofing membrane intended for use in external applications.

Roof & Gutter Repair Tape is a self-adhesive, bitumen-impregnated tape intended for use as a flashing and sealant of roofs and gutters.

Rubberguard Peel and Stick Tape is a self-adhesive tape intended for use as reinforcing to corners and junctions.

SCOPE OF USE & LIMITATIONS

The membrane and tape are intended for use as a waterproofing system for the following roof and gutter substrates.

- cementitious
- · metal, and
- timber

The system must be applied to a structurally sound, securely fastened and supported substrate. This will avoid substrate movement related cracking. The substrate should also be dry.

Where the system is it to be used over a cementitious substrate, then the surface should be primed with a Cemix primer.

The tapes must never be used as an exposed flashing. Roof & Gutter Repair Tape cannot be applied to masonry.

The membrane can be left exposed or painted over. It should not be applied if the humidity is > 85% or if rain is expected within 48 hours.

When used in building work, the Roof & Gutter Waterproofing system will contribute to building code compliance of the building work.
