## DESCRIPTION OF BUILDING PRODUCT

Cemix Grout Sealer is a clear, water-based, polyurethane-based sealer for grout. It is supplied for use where tiles are being laid vertically and/or horizontally in wet areas, and in interior and exterior applications.

The grout must be left to cure for at least 48 hours prior to application of the sealer.

Grout sealer must be cleaned off the tile surface as it can leave a hard, milky coating.

## CONTRIBUTION TO BUILDING WORK CODE OBLIGATIONS

The Cemix Grout Sealer does not have building code obligations. Code contribution arises when used to seal grout between tiles.

B2 (Durability), B2.3.1(c). Contributes to the durability of the joints between the tiles where the grout has been applied.

E2 (External Moisture), applicable performance criteria. Will contribute to the impermeability of the joints between the tiles where the grout has been applied.

E3 (Internal Moisture), applicable performance criteria. Will contribute to the imperviousness of the joints between the tiles where the grout has been applied.

F2 (Hazardous Building Materials), F2.3.1. Once cured, the sealer will not emit harmful gases.
